I received a copy of the consultation email and I thought it might be helpful to let you know that there is an anomaly within the Schedule 7 drafting that is inconsistent with the current model clause drafting as well as the recent modifications approved by ORR that relate to ADDR rules etc. Paragraph 9.4 of Part 2 to Schedule 7 makes reference to Chapter F of the Rules – this appears to be an error that crept into the drafting when the industry-wide version was being prepared. The correct drafting is set out below and you may want to amend your template accordingly.

9.4 If the parties shall have failed to agree such supplements or changes within 45 days of the date of the notice given under paragraph 9.3, either party shall be entitled to refer the matter for resolution in accordance with the ADRR.
