Thank you for your request of 29 January 2018. You requested the following information for the 2016-17 financial year:

- '1. How much did Network Rail spend approx. in 2016-17 for asbestos removal. This to include removals to all buildings and assets demolition and fly tipping*
- 2. Is the work carried out by internal staff or external contractors.*
- 3. If both, what is the percentage split.*
- 4. If external contractors are used, what are the start and end dates of the contracts.*
- 5. What are the names of the external contractors.'*

I have processed your request under the Environmental Information Regulations 2004 (EIR) as the information requested is environmental according to the definition in regulation 2 of the EIR (section 39 of the Freedom of Information Act 2000 (FOIA) exempts environmental information from the FOIA, but requires us to consider it under the EIR).

I can confirm that we hold the information you requested.

*1. How much did Network Rail spend approx. in 2016-17 for asbestos removal. This to include removals to all buildings and assets demolition and fly tipping.*

In 2016-17 we spent approximately £620,000 on asbestos removal – this comprises approximately £260,000 under a framework agreement and a further £360,000 through principal contractors who manage the service directly with asbestos removal suppliers.

*2. Is the work carried out by internal staff or external contactors.*

*3. If both, what is the percentage split.*

Services are supplied through contracted suppliers; work is not carried out by internal staff, so there is no percentage split.

*4. If external contractors are used, what are the start and end dates of the contracts.*

The Removal of Asbestos Contaminated Materials framework runs from 1 May 2015 to 30 April 2018 (with an option to extend for a further one year, plus one year to 2020).

*5. What are the names of the external contractors.*

Suppliers on the framework mentioned above are Rhodar, Reactive Integrated Services, Ductclean, OCS, Clifford Devlin and Aspect Contracts.

*6. How are the contracts procured.*

Network Rail runs an online tendering process which is compliant with European Union requirements for procurement. The website address for tendering opportunities relating to Network Rail is <https://networkrail.bravosolution.co.uk/web/login.html>
